**IN RETURN FOR THE USE OF THE FACILITIES AND/OR ANY OTHER CONSIDERATIONS,  
I STATE AND AGREE THAT:**

- 1) I am aware that paintball is a physically demanding and mentally strenuous game involving possible risk of injury from equipment, other players and playing environment. I acknowledge that this is the intent of other player's to assault me during the game and in order to do so, other player's will try to overcome my resistance that I may exert by the use of an air gun, referred to below, which is a gun powered by CO2 cartridges that exert a pressure of 800 pounds per square inch and range of approximately 100 feet. The paintballs are biodegradable shell and dye projected from the gun.
- 2) I hereby undertake and assume total responsibility for any risk or injury associated with playing or participating in paintball games.
- 3) I undertake to play in accordance to the safety instructions, rules and guidelines, which I have hereby acknowledged as having read and understood.
- 4) I am aware that Rampage Paintball Ltd. does not warrant the condition or safety of the equipment, facilities or premises, natural or constructed, or the availability of medical care connected to Rampage Paintball Ltd.
- 5) I understand that Rampage Paintball Ltd., their respected officers, agents, employees and associated personnel are NOT insured for liability that may attach them by having agreed to play at Rampage Paintball.
- 6) I hereby for myself, heirs, executive, administrators, successors, and assignees IDEMNIFY and SAVE HARMELSS and keep indemnified Rampage Paintball Ltd., their equipment, manufacturers, suppliers, as well as staff, agents employees, promoters, officers, directors, shareholders, guests, invitees and aforementioned from and against any and all actions, claims, costs, expenses or demands including legal fees, in respect of death, injury, loss or damage to the person or property of myself, or any participant, guest, however caused, arising out of or in connection with my playing and attending the premises on which is offered paintball games. Rampage Paintball Ltd. is played and notwithstanding that the same may have been contributed to or occasioned by negligence of the said parties, their respected staff, instructors, guests, assignees other player's, and which negligence may relate, without any limiting the generality of the forgoing, to manufacture, selection, delivery, possession, use and operation of equipment and supplies, and the selection of maintenance of the premises and the conduct and suppression of paintball games.
- 7) I expressly agree that the foregoing waiver is intended to be as broad and inclusive as is permitted by the law of the Province of Alberta in which paintball games is conducted and that if any portion is held invalid, it is agreed that the balance shall, nevertheless, continue in full force and effect.
- 8) I hereby certify that I have read and understood this waiver in it's entirety, and that I have executed same as my own free will without incurring any duress whatsoever. I acknowledge that I have the right to withdraw from the said game at any time.
- 9) I am at least 18 years of age and in good mental health and if I am under 18 years of age, I will have a parent or guardian signature allowing me to participate in the game.
- 10) I accept full responsibility for the return or replacement value, as determined by Rampage Paintball Ltd., of the equipment upon the termination of the game.
- 11) I have read and fully understand this agreement and recognize it as legal and binding.
